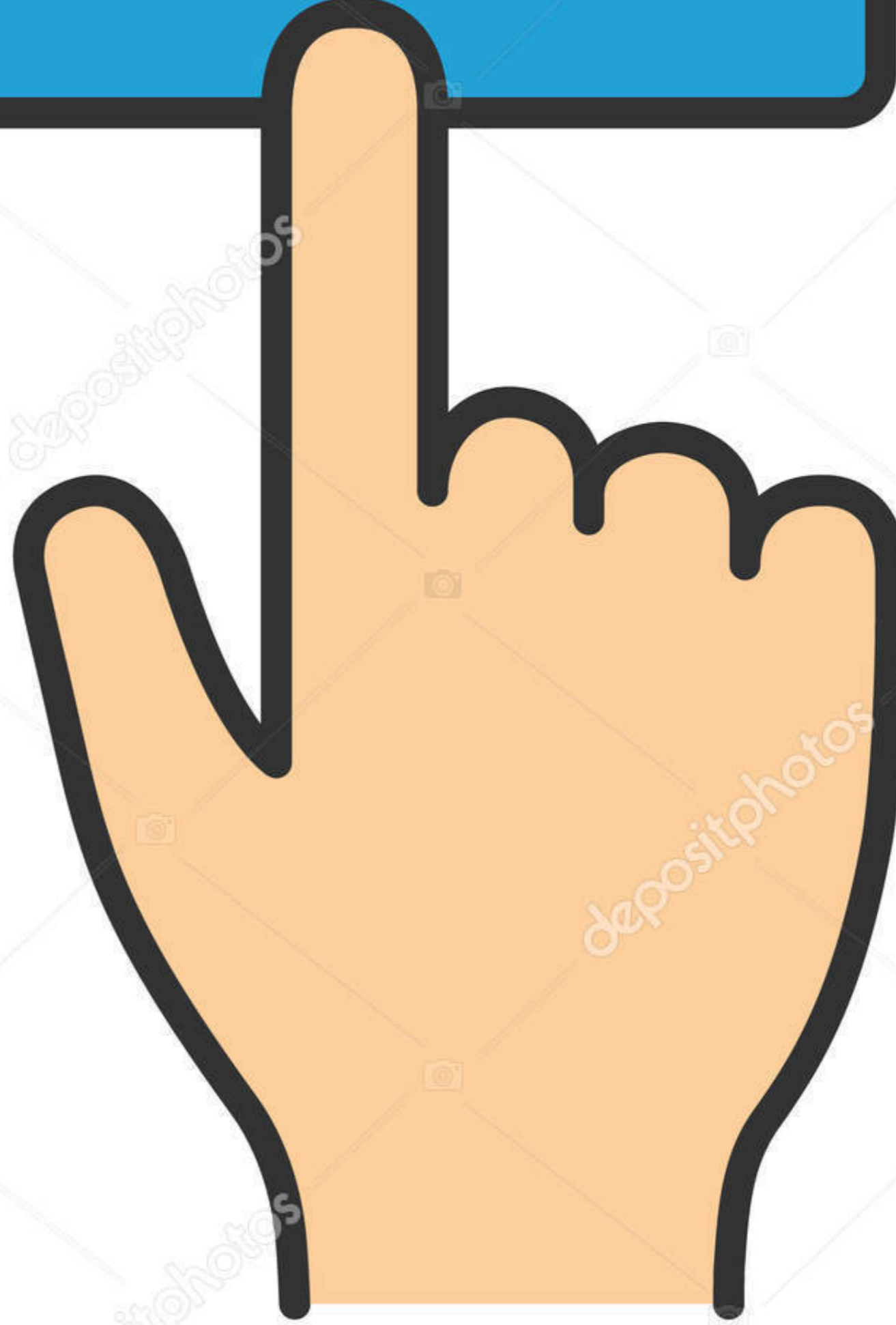

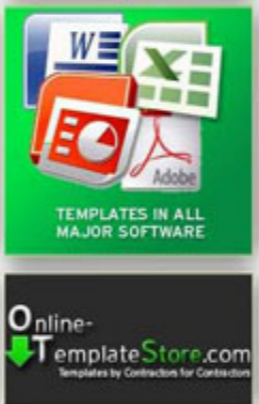

**SPECIAL CONDITIONS OF SUB-CONTRACT**

- The terms and conditions upon which COMPANY contracts with any sub-contractor for the performance of any work and/or the supply of materials and/or goods shall be deemed to be the conditions of sub-contract as set out in the standard form of sub-contract stated to be applicable in COMPANY's Letter of Acceptance (the Standard Sub-Contract Conditions of the Invited Tender) and the relevant terms of the principal contract (together referred to hereunder as the "Contract Documents").
- In the event of any conflict between the provisions of the Contract Documents and the provisions of the Invitation to Tender, the Letter of Acceptance or the Standard Sub-Contract Conditions of the Invited Tender, the provisions of the Contract Documents shall prevail.
- The Sub-Contractor's tender/offers shall be deemed to be in accordance with the terms, conditions and descriptions of the Contract Documents and shall be deemed to be in accordance with the terms, conditions and descriptions of the Contract Documents and shall be deemed to be in accordance with the terms, conditions and descriptions of the Contract Documents.

- The Sub-Contractor will comply with the terms and conditions of the Contract Documents and shall be deemed to be in accordance with the terms, conditions and descriptions of the Contract Documents.
- In the event that the Sub-Contractor shall fail to bring the Sub-Contract Works (or any of the parts or stages thereof for which separate completion dates are set) to completion by the date/s set for such completion
